All currency conversions used in the creation of this report have been calculated using constant annual average 2022 exchange rates.
- The Scandinavian Beer & Cider market had total revenues of \$10,571.1 million in 2022, representing a compound annual growth rate (CAGR) of 2.2% between 2017 and 2022.
- Market consumption volume increased with a CAGR of 1.5% between 2017 and 2022, to reach a total of 1,675.3 million liters in 2022.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 4% for the five-year period 2022 - 2027, which is expected to drive the market to a value of \$12,840.0 million by the end of 2027.
