Retail volume of sales of nappies/diapers/pants in Uruguay fell considerably in 2023, due to the ongoing decline in the country's birth rate. In addition, small-scale smuggling from Argentina also impacted local retailers' sales, although the impact was far less severe than in other tissue and hygiene categories.
