Report description:

In 2023, store cards in Germany faced stagnant development. Despite a brief resurgence in 2021 and 2022, the category has struggled to return to pre-pandemic levels. The decline is attributed to the growing consumer preference for alternative loyalty programmes and digital payment methods. The pandemic has accelerated the shift towards e-commerce, making the store-based concept of store cards less appealing to consumers and costly for retailers to maintain.

Euromonitor International's Store Card Transactions in Germany report establishes the size and structure of the market for ATMs cards, smart cards, credit cards, debit cards, charge cards, pre-paid cards and store cards.
