That said, the return to foodservice does somewhat place downwards pressure on potential sales, when compared to the era of home seclusion during the pandemic; although, we also note that many companies in Austria continue to operate hybrid working policies, whereby employees work from home certain days of the week and, thus, cook lunch at home on those days.
