The global cannabis seeds market was valued at \$1.3 billion in 2021, and is projected to reach \$6.5 billion by 2031, growing at a CAGR of 18.4% from 2022 to 2031. After successfully germinating or when the seed's protective shell has been breached by the root, cannabis seeds are prepared for planting and growing. Regular, feminized, and auto-flowering cannabis seeds can all be found online. For the adult plant to be a blooming female, home gardeners of cannabis frequently select feminized seeds. Cannabis produces seeds that contain all of the genetic material required for development and reproduction, as do all angiosperms, or flowering plants. When a seed is sown, the genetic material's translation determines each distinct physical trait the mature plant will have. If these are desired features, like potency, fragrance, strength, etc., a breeder can choose for these through a long process of genetic stability through generations, which finally leads to the development of a cultivar, or strain. The global cannabis seeds market is analyzed on the basis of nature, type, distribution channel, and region. By nature, the market is divided into organic and conventional. By type, the market is divided into feminized seeds, regular seeds, and autoflowering seeds. By distribution channel, it is classified into specialty stores, wholesalers and distributors, and online sales channel. Region wise, the market is analyzed across North America (the U.S., Canada, and Mexico), Europe (Germany, Italy, Denmark, Poland, the UK, and the rest of Europe), Asia-Pacific (Thailand, Australia, New Zealand, and the rest of Asia-Pacific), and LAMEA (Brazil, South Africa, and Rest of LAMEA).

The impact of the COVID-19 outbreak was negative on the growth of the global cannabis seeds market. The trade restrictions and lockdown resulted into halting of production and manufacturing units. Conversely, the recovery of the cannabis seeds market is expected in near future.

In the future, the cannabis seeds market's growth rate will be further accelerated by the ongoing genetic evolution and
