categorized into passenger handling, ramp handling, cargo handling, and others. By airport, the market is divided into domestic and international. Depending on the provider, the market is classified into independent, and airlines & airports.□

The five forces include the bargaining power of buyers, the bargaining power of suppliers, the threat of new entrants, the threat of substitutes, and the level of competitive rivalry. The bargaining power of suppliers is influenced by the scarcity of specialized equipment and expertise required for ground handling services. This, in turn, gives suppliers some leverage in negotiations. The bargaining power of buyers is significant. Airlines and airports have several options when selecting ground handling providers, and they can be highly demanding in terms of service quality and cost-effectiveness. The threat of new entrants is relatively low due to the substantial capital investment required to establish ground handling operations. In addition, existing players often benefit from economies of scale and established relationships. The threat of substitutes is limited, as ground handling services are integral to airport operations. While some services can be performed in-house by airlines and airports, specialized tasks necessitate external providers. The level of competitive rivalry within the market is intense due to the presence of several independent providers, airlines, and airports competing for business. This competition drives innovation and service improvements.□

The strengths of the market lie in its essential role in the aviation industry, ensuring the smooth functioning of airports. It is a crucial factor in the travel experience, creating demand for its services. The weaknesses include the high degree of complexity and regulatory constraints.
