Report description:

The restaurant management software market was valued at \$4,236.4 million in 2021, and is projected to reach \$17,113.9 million by 2031, registering a CAGR of 15.3% from 2022 to 2031. The purchasing & inventory management segment was the highest revenue contributor to the market, with \$974.8 million in 2021, and is estimated to reach \$5,719.1 million by 2031, with a CAGR of 19.6%. The front end solution segment is estimated to reach \$3,663.3 million by 2031, at a significant CAGR of 17.2% during the forecast period.

The restaurant management software market share is predicted to expand significantly during the forecast period due to increased Metadata protection. Furthermore, the expansion of the market is fuelled by the increase in usage of digitalization and artificial intelligence (AI). However, the high initial cost of installation and administration is the key factor constraining market expansion. On the contrary, increased market penetration across different end-use verticals is expected to propel restaurant management software market growth.

The restaurant management software market research is segmented into solution, deployment, end-use vertical and regions. On the basis of solution, the market is bifurcated into front-end solution, accounting & cash flow solution, purchasing & inventory management, table & delivery management, employee payroll & scheduling and others.
