The global beauveria bassiana market was valued at \$89.2 million in 2022, and is projected to reach \$195.1 million by 2032, registering a CAGR of 8.4% from 2023 to 2032. Beauveria bassiana is a species of fungus known for its insecticidal properties, used in biological pest control. It naturally occurs in soils and infects various insect pests, including beetles, flies, and mosquitoes. This fungus penetrates the exoskeleton of insects, proliferates inside, and eventually kills the host. The fungus is commercially formulated into biopesticides, offering an eco-friendly alternative to chemical insecticides. Beauveria bassiana is favored for its specificity, targeting pests while sparing beneficial organisms. Its efficacy, environmental safety, and compatibility with integrated pest management strategies make it a valuable product in agriculture, forestry, and public health efforts to manage insect populations sustainably.

Rise in concerns among consumers over pesticide residue in food have significantly surged the market demand for beauveria bassiana as a safer and more sustainable alternative for pest control in agriculture. Consumers are becoming increasingly aware of the potential health risks associated with consuming food contaminated with chemical pesticides. Thus, there is a growing preference for food crops produced using eco-friendly biopesticides such as beauveria bassiana, as it offers a safer and more sustainable alternative to chemical pesticides, with minimal environmental impact and lower health risks. For instance, in countries such as China, the U.S., Argentina, Thailand, Brazil, Italy, France, Canada, Japan and India, intensive pesticide use has led to high levels of contamination in fruits and vegetables. As a result, consumers are seeking organic and pesticide-free options. Rise in demand for chemical free food has created a market demand for crops grown with biological pest control agents such as beauveria bassiana, which leave minimal residue and pose no harm to human health.

Furthermore, retailers and food companies are responding to consumer preferences by sourcing products from farmers who employ sustainable pest control practices, including the use of biopesticides. In addition, regulatory bodies are imposing strict limits on pesticide residues in food, further incentivizing farmers to adopt safer alternatives such as beauveria bassiana. As a

Beauveria bassiana fungus effectively targets a wide range of agricultural pests, including beetles, caterpillars, and aphids, while posing minimal risk to non-target organisms and the environment. As farmers seek eco-friendly alternatives to conventional pesticides, the demand for beauveria bassiana products has surged, creating a lucrative market for suppliers and manufacturers.

Moreover, the adoption of integrated pest management (IPM) practices further drives the demand for beauveria bassiana in agriculture.
