#### Philippines Dialysis Market Overview

The Philippines dialysis market is estimated to grow at a compound annual growth rate (CAGR) of 5.2% from 2017 to 2032.The market is driven by the increasing prevalence of chronic kidney disease (CKD) and end-stage renal disease (ESRD) in the country, which is attributed to the high incidence of diabetes, hypertension, obesity and aging population. According to the Philippine Renal Disease Registry, there were about 36,000 ESRD patients in 2017, of which 86% were undergoing dialysis treatment. The demand for dialysis services is expected to increase further as the number of ESRD patients is projected to reach 58,000 by 2022 and 95,000 by 2032.

Philippines Dialysis Market Drivers and Constraints

The Philippines dialysis market is also supported by the favorable government policies and initiatives, such as the Universal Health Care Act, the PhilHealth Z Benefit Package for ESRD, the National Kidney and Transplant Institute Act, and the Philippine Organ Donation and Transplantation Program. These factors hamper the growth and development of the market and pose significant barriers to the delivery and utilization of dialysis services in the country.
