- The Singaporean Pet healthcare market had total revenues of \$10.2 million in 2023, representing a compound annual growth rate (CAGR) of 5% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.8% between 2018 and 2023, to reach a total of 11.2 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.7% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$13.5 million by the end of 2028.
