- Market consumption volume increased with a CAGR of 1.8% between 2018 and 2023, to reach a total of 1,018.7 TWh in 2023.
- According to GlobalData, in 2023, electricity consumption in Russia witnessed an annual growth of 1.1% due to the rise in demand from industrial users. According to the Federal State Statistics Service, in October 2023, industrial production in Russia witnessed an annual growth of 5.3%, which has driven electricity consumption.
