- Market consumption volume increased with a CAGR of 2.6% between 2018 and 2023, to reach a total of 109.5 million units in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 5.1% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$1,034.9 million by the end of 2028.
