- The Turkish Dog care market had total revenues of \$115.5 million in 2023, representing a compound annual growth rate (CAGR) of 36.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 4.8% between 2018 and 2023, to reach a total of 16.3 million kilograms in 2023.
- The performance of the market is forecast to decelerate, with an anticipated CAGR of 16.1% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$243.1 million by the end of 2028.
