- The Asia-Pacific Pet healthcare market had total revenues of \$3,289.8 million in 2023, representing a compound annual growth rate (CAGR) of 4.4% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 2.5% between 2018 and 2023, to reach a total of 440.5 million units in 2023.
- The performance of the market is forecast to follow a similar pattern with an anticipated CAGR of 4.4% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$4,086.7 million by the end of 2028.
