This growth was driven by government IT initiatives and robust export growth in the IT sector. The nominal GDP reached INR508.0 billion (\$6.2 billion) in 2023, up from INR461.0 billion (\$5.8 billion) in 2022. Advancements in the logistics sector, a favorable startup policy, traditional technology sector investments, renewable energy investments, and an expanding education sector are expected to support growth in high-value sectors in the Union Territory

- The service sector mainly drives the economic growth of the area, accounting for 89.0% of the total GDP in 2023
- Chandigarh, a key IT and ITeS hub in North India, prioritizes these sectors due to limited space for manufacturing and its landlocked nature. This focus aligns with its carbon neutrality goals. The adoption of the Startup Policy 2022 aims to boost the startup ecosystem and support sector growth. Software exports from Chandigarh saw significant growth, reaching INR40.9 billion (\$552.8 million) in 2021-22, making it the leading export sector in the region with a 14.1% annual growth rate.
