In Austria, retail volume sales of cigarettes experienced a notable decline in 2023, falling below pre-COVID-19 levels for the first time. This decline follows a pandemic-induced increase when travel restrictions limited access to cheaper cigarettes from neighbouring countries. Despite this, the Austrian government did not take significant measures to discourage smoking, with moderate tobacco tax increases resulting in only gradual cigarette price hikes, even amid strong inflation.
