In 2023, the collective weight of inflationary pressures, waning consumer confidence, and persistent brand boycotts led total volume sales of alcoholic drinks in the US to drop to their lowest level in a decade. For instance, while malt-based RTDs flew off shelves, largely as hard tea and spirit-based canned cocktails saw share growth, hard seltzers continued their fa...
