With the entry of the new government in January 2023, the new Minister of Treasury decreased the taxes on single use e-cigs and refillable liquid from 270% to 145% with an additional ILS4.64/ml. However, overall tax cannot be lower than ILS8.9/ml. The tax on single use products is based on the amount of liquid inside the product. The tax that the previous Minister of Treasury had put into effect had expired. In February, the new Minister of Treasury, Smotrich, proposed a lower tax of 145%. In Ma...
