Spirits in the UK experienced another weak performance in 2023, recording both on-trade and off-trade volume declines. Sales via the on-trade channel were negatively impacted by high cost of living and the desire among local consumers to save money, leading to a lower frequency of visits to bars, pubs and restaurants. Meanwhile, despite the volume decline, many local consumers continued to drink spirits at home instead of on-trade establishments, favouring the convenience and relatively lower pr...
