Following a double-digit contraction in 2022, tobacco in Costa Rica showed a modest return to growth in total current value sales in 2023. The overall performance of the market in volume terms continued to be undermined by falling demand for cigarettes, the dominant product type, though the rate of decline was markedly slower than in the previous year, and most other categories expanded in this regard. These results were facilitated by a dramatic reduction in domestic inflation amidst the rapid...
