Total volume sales of beer in Slovakia continued to decline in 2023, albeit at a slower rate than the previous year. Growth was impacted by mounting inflationary pressures, which weighed heavily on consumer purchasing power. While beer benefited from more a favourable regulatory environment than spirits, which saw an increase in excise duty during the year, demand for the former was curtailed by unseasonably cold temperatures during spring and early summer, which ensured that the industry stayed...
