While legal cigarette volumes declined in 2023, illicit sales continued to grow. The Indonesian Government increased the tobacco excise tax (CHT) rates by an average of 10% for cigarettes, 15% for electronic cigarettes and 6% for any other processed tobacco products, starting fr...
