Sales of ice cream declined sharply in retail volume terms in 2023, with France experiencing lower temperatures and greater instability in the weather than in 2022. Whilst value sales grew this was due to price rises, with volume sales fell across every category with the exception of plant-based ice cream. Due to an increase in the cost of key ingredients such as sugar and cocoa, the cost of producing ice cream has risen substantially. With manufacturers under pressure to raise their prices cons...
