This is attributed to the normalisation effect following the atypical spikes and crashes seen in sales through the pandemic era and the following reopening of society. Specifically for RTDs, such products depend strongly on off-trade sales, due to their very nature of being ready-mixed drinks. Therefore, the reopening of foodservice meant lower volumes of sales overall, as con...
