RTDs in Slovakia registered a decline in total volume terms ion 2023, in contrast to the positive performances of the previous two years. Inflationary pressures, which translated into higher production costs, led to an increase in retail unit prices, which in turn, had a negative impact on off-trade demand. Nevertheless, many Slovak consumers continued to enjoy RTDs at home, pressured by the difficult economic situation. There was also a shift away from wine-based RTDs towards spirit-based RTDs,...
