Snacks in Azerbaijan is poised to record a moderate slowdown in current value sales growth in 2024, but show a slightly improved performance in retail volume growth terms. This is mainly explained by the gradual easing of inflationary pressures related to the global recovery from COVID-19 and Russia's invasion of Ukraine. Falling inflation has reduced the extent and scale of unit price hikes as compared to 2023, while simultaneously bolstering confidence and disposable incomes among consumers. G...
