Total volume sales stagnated in spirits as household budgets remained under pressure in Latvia from the high costs of living. The strong performance in 2022 was fuelled by the relaxation of pandemic restrictions, which boosted sales in horeca establishments. Although consumers began to return and spend money in cafes and restaurants, spending behaviour became subdued as the war in Ukraine took hold. Utility bills in Latvia have increased significantly in recent years with cost-of-living pressure...
