Wine consumption remained low in the Dominican Republic in 2023, and also registered a significant drop in volume sales. With the economy spluttering, particularly in the first half of 2023, consumers cut down on wine consumption. That being said, volume sales increased through on-trade channels, largely due to the increased number of foreign tourists. However, volume sales are significantly lower through foodservice than through retail.
