- The South African casinos & gaming sector recorded revenues of \$2,895.4 million in 2023, representing a compound annual growth rate (CAGR) of 5.6% between 2018 and 2023.
- The sports betting and related segment accounted for the sector's largest proportion in 2023, with total revenues of \$1,526.6 million, equivalent to 52.7% of the sector's overall value.
- The National Gambling Board (NGB) of South Africa reported that sports betting has grown from ZAR8.8 billion (\$480 million) between 2019 and 2020 to ZAR23.7 billion (\$1.2 billion) between 2022 and 2023.
