As the transportation sector experiences steady growth, fueled by increased demand for the movement of goods and people, there arises a corresponding need for robust transportation solutions, including medium and heavy trucks, to support these activities efficiently. For instance, according to MarketLine, the Canadian road transportation services industry stood at \$34.2 billion in 2023, an increase of 3.8% from the previous year.
