- Market consumption volume increased with a CAGR of 2.4% between 2018 and 2023, to reach a total of 136.2 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 10.3% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$3,961.7 million by the end of 2028.
