- The US Wine market had total revenues of \$48,310.3 million in 2023, representing a compound annual growth rate (CAGR) of 1.8% between 2018 and 2023.
- Market consumption volumes declined with a negative CAGR of 0.2% between 2018 and 2023, to reach a total of 3,662.7 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 2.8% for the five-year period 2023 2028, which is expected to drive the market to a value of \$55,477.1 million by the end of 2028.
