- The Brazilian Wine market had total revenues of \$4,034.9 million in 2023, representing a compound annual growth rate (CAGR) of 3.8% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 1.9% between 2018 and 2023, to reach a total of 359.1 million liters in 2023.
- The performance of the market is forecast to accelerate, with an anticipated CAGR of 6.2% for the five-year period 2023 - 2028, which is expected to drive the market to a value of \$5,448.0 million by the end of 2028.
