- Sector consumption volumes declined with a negative CAGR of 4.4% between 2018 and 2023, to reach a total of 902.1 million FTK in 2023.
- The growth in the Indonesian air freight sector is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Indonesia reached 99.05 in February 2023, up from 98.79 in September 2022.
