- The Japanese control systems market recorded revenues of \$1,965.2 million in 2023, representing a negative compound annual growth rate (CAGR) of 5.6% between 2018 and 2023.
- The DCS segment accounted for the market's largest proportion in 2023, with total revenues of \$1,157.2 million, equivalent to 58.9% of the market's overall value.
- . The market recorded contraction between 2018 and 2023. This contraction is attributed to low domestic demand, rising inflation, weak private consumption, and slowing global demand impacting exports.
