- Sector consumption volumes declined with a negative CAGR of 7.2% between 2018 and 2023, to reach a total of 1,395 million FTK in 2023.
- The growth in the Australian air freight sector is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in Australia reached 100.22 in August 2023, up from 99.84 in December 2022.
