The value of the oil segment reflects the total volume of refined petroleum products, including refinery consumption and losses, multiplied by the average retail price of gasoline and diesel taken together. The value of the gas segment is calculated as the total volume of natural gas consumed multiplied by the retail price of natural gas.
- The Irish oil & gas market recorded revenues of \$17.3 billion in 2023, representing a compound annual growth rate (CAGR) of 2.2% between 2018 and 2023.
- Market consumption volume increased with a CAGR of 0.8% between 2018 and 2023, to reach a total of 92.3 million BoE in 2023.
- The contraction?in the oil &?gas market?in recent years can be attributed to the growing sales of electric vehicles. According to MarketLine, the Irish hybrid and electric cars market stood at \$2.9 billion in 2023, an increase of 18.5% from the previous year.
