- The retailer segment accounted for the industry's largest proportion in 2023, with total revenues of \$920.1 million, equivalent to 21.5% of the industry's overall value.
- The rise in the media and telecommunications sector notably influences the advertising industry as the broader reach and targeted advertising capabilities offered by these platforms contribute to the growth of the advertising industry. According to MarketLine, the media and telecommunications industry witnessed a significant rise of 3.3% in 2023, reaching \$782.3 million compared to the previous year.
