- The growth in the European air freight sector is influenced by several macroeconomic factors, such as rising GDP and growing business confidence. For instance, according to the Organisation for Economic Co-operation and Development (OECD), the business confidence index in the UK reached 99.6 in January 2023, up from 96.8 in May 2020.
