- The Scandinavian IT services industry registered revenues of \$27.9 million in 2023, representing a compound annual growth rate (CAGR) of 7.8% between 2018 and 2023.
- The infrastructure services segment accounted for the industry's largest proportion in 2023, with total revenues of \$17 million, equivalent to 61% of the industry's overall value.
- Sweden is witnessing an expanding ICT industry and accounts for a share of 40.0% share of the total IT spend in the Nordics, according to the data from NASSCOM, a not-for-profit industry association.
