- Among the G8 nations, the US is the leading country in the banks industry, with market revenues of \$23,232.5 billion in 2023. This was followed by France and Japan, with a value of \$14,091.5 and \$13,022.6 billion, respectively.
- The US is expected to lead the banks industry in the G8 nations with a value of \$28,960.2 billion in 2028, followed by Germany and France with expected values of \$17,418.8 and \$17,412.2 billion, respectively.
