Sweden saw beer volume sales stagnate in 2023. The flat performance for total volume sales of beer resulted from the rise in on-trade volumes being offset by a fall in off-trade sales during the year. The category's growth was constrained by the high rate of inflation, elevated electricity prices, high interest rates and a weakened Swedish kroner.
