Inflationary pressures weakened considerably in 2024 although the price of snacks in Austria remained high and increased slightly across a number of categories. Although the cost of energy decreased slightly, commodities including cocoa, potatoes and sugar remained costly for manufacturers. Total volume sales of snacks grew slightly in 2024 with a slightly better performance year on year. This healthy performance reflects stable consumer demand in most product snack categories.
