The Vietnam recycled plastics market size reached 270.1 Kilo Tons in 2023. Looking forward, IMARC Group expects the market to reach 532.4 Kilo Tons by 2032, exhibiting a growth rate (CAGR) of 7.6% during 2024-2032.

Plastic is present around us in huge quantities and accounts for almost 90% of the global municipal waste. This waste gets accumulated on land that can be used for other purposes, and thus recycling plastic offers an effective solution for clearing these landfill spaces. Plastic recycling includes the reprocessing of post-consumer or post-industrial plastics instead of the virgin resin.
