- Within the wireless telecommunication services industry, China is the leading country among the BRIC nations with market revenues of \$142.5 billion in 2023. This was followed by India, Brazil and Russia with a value of \$27.7, \$16.0, and \$13.6 billion, respectively.
- China is expected to lead the wireless telecommunication services industry in the BRIC nations with a value of \$158.6 billion in 2028, followed by India, Brazil, Russia with expected values of \$32.6, \$20.1 and \$15.8 billion, respectively.
