- The North American Free Trade Agreement (NAFTA) is a trade agreement between the countries in North America: the US, Canada and Mexico. The internet access industry within the NAFTA countries had a total market value of \$1,46,469.3 million in 2023. The US was the fastest growing country, with a CAGR of 7.6% over the 2019-23 period.
- Within the internet access industry, the US is the leading country among the NAFTA bloc, with market revenues of \$1,28,452.6 million in 2023. This was followed by Canada and Mexico, with a value of \$11,049.1 and \$6,967.7 million, respectively.
- The US is expected to lead the internet access industry in the NAFTA bloc, with a value of \$1,46,940.8 million in 2028, followed by Canada and Mexico with expected values of \$12,823.0 and \$8,642.2 million, respectively.
