Report description:

Retail volume and current value growth rates for snacks in Bolivia in 2024 are expected to be slower than those recorded in 2023. The downturn is mainly explained by a severe shortage of US dollars in the economy resulting from declining production of natural gas, which has been the country's primary source of export revenues in recent decades. Together with a fixed exchange rate, dwindling foreign reserves have made importing finished products and essential raw materials significantly more expensive.
