Over 2024, retail volume sales of snacks in Tanzania are set to grow marginally faster than in 2023, supported by a fuller return to pre-COVID-19 lifestyles, population growth, urbanisation, a wider offer and distribution and unit price stabilisation. However, prices are significantly higher than in the early-to-mid-review period and affordability remains a key constraint on demand. Thus, promotions, and smaller packs, remain important demand drivers, if slowing retail current value growth.
