This move reflects broader market trends towards improved logistics networks and increased capacity to meet rising consumer expectations for faster, more reliable delivery services.

The e-commerce logistics industry is classified on the basis of service, operation, function, business model, delivery model, product category, and region.

The food and grocery segment will witness a considerable surge between 2024 and 2032, attributed to the growing trend of online grocery shopping and the need for efficient, temperature-controlled delivery solutions. Consumers increasingly seek the convenience of ordering groceries online, driving demand for reliable and timely logistics services. The complexity of handling perishable goods and maintaining product quality during transit further fuels the growth of this segment. As online grocery sales continue to rise, the food and grocery segment will hold a decent share of the e-commerce logistics market.

The same-day delivery segment will undergo a remarkable uptick through 2032, driven by consumer demand for faster shipping options for convenience and immediacy. Advances in logistics technology and streamlined supply chain processes enable retailers to offer quick delivery services, enhancing customer satisfaction and driving repeat business. The growing emphasis on rapid fulfillment and competitive market pressures will further propel the expansion of same-day delivery services, solidifying their crucial role in the e-commerce logistics industry.

North America e-commerce logistics market will register a noteworthy expansion from 2024 to 2032, owing to its advanced
