- The Belgian automotive manufacturing industry recorded revenues of \$7.1 billion in 2023, representing a compound annual growth rate (CAGR) of 5.9% between 2018 and 2023.
- Industry production volume increased with a CAGR of 0.9% between 2018 and 2023, to reach a total of 0.3 million units in 2023.
- The production growth across the industry is supported by rising domestic consumption and the accelerating exports of automobiles. According to the Belgian Federation of Automobile and Cycle Industry (FEBIAC), in 2023, 476,675 new passenger cars were registered in Belgium, up 30% over 2022.
